7. Funding

Big Lottery Funding Application

Funding bid nearly ready. First part unchanged.

Financial section. Steve has copies of all quotes for work to send with bid. Match funding and in kind amounts have been reached. Still awaiting some letters/support documents for in kind work (topsoil and hardcore). Suzanne still awaiting quotes for haulage.

(Talking of in kind work, Michael commended Andy on our website, which is a comprehensive record of our progress so far, an excellent communication tool and a possible source of funds. We all want to express our thanks to Andy for all his hard work.)

Aim to send bid to Morag by end of week for her comments then submit final Bid as soon as possible. If successful should have money by end August. If unsuccessful we'll apply elsewhere and make full use of in kind offers.

Suzanne to check if £250 grant from ERYC is time limited. Can buy raised beds and compost bins now if necessary. Further funding may also be available from ERYC. Suzanne to check.

8. Field Development Progress

Field has been sprayed with glyphosate (Round Up) to kill weeds before work starts. Glyphosate dissipates when it hits the soil and is safe for allotments and food crops so is in keeping with our environmental policy. Should be effective within a month.

It was suggested that we scoop soil from banks at sides and rear of field to utilise as much of our own top soil as possible and reduce need for haulage, which is expensive, environmentally unfriendly and disruptive to local community. This would require a big digger which we need to find. Also suggested that level need not be as high as we originally planned, which would also reduce need for haulage and not require planning permisssion. Suzanne to

	contact planners again with new plans to raise level by only 150 mm to level contours on the site.					
	 Plan of action is as follows: Enlarge entrance – crown 2 trees, remove gate and some hedging. Need temporary solution to block entrance when not in use. May need to raise levels near entrance to allow ingress of lorries and digger. Possibly use road plates to protect verge. Lay planings to provide hard standing for lorries/digger? Big digger to scoop soil from ends and banks and use to even out holes. Also to dig drainage channel to back end of field. Import topsoil and spread out. 					
	Suzanne suggested Mark would generally be available to deal with contractors. Eventually need new gate. Could possibly be provided by Council. Need to source planings. Available from Council but have to register with them.					
9.	Any Other Business Opening Ceremony Plan to hold opening ceremony when we're up and running, probably June 2011. Michael to make enquiries about the possiblility of Prince Charles opening the allotments. All to think of alternatives.
